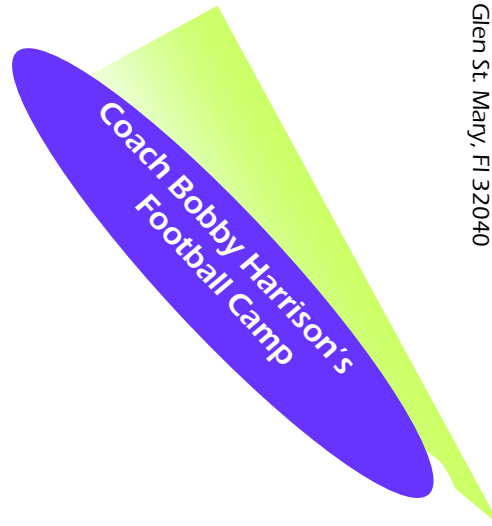

Prior to arriving at Snyder, Coach Harrison was at Baker County High School for 21 years and at Fernandina Beach High School for 10 years in teaching and coaching capacities.

He is joined by his son, Greg, who has coached for ten years and played football at Carson Newman College in Tennessee.

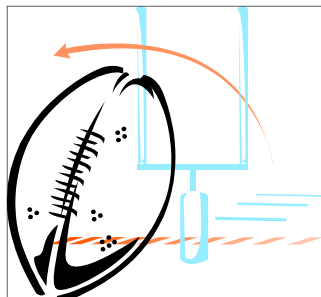
Jon Mobley has been coaching football since 1994 at Paxon High School and Baker County High School. He played football for Southwest College in Nebraska.

## What to Expect at Camp

Your son will participate in conditioning drills and basic weight training activities. There will be emphasis on quarterback techniques and running back play. Drills for punting and place kicking as well blocking techniques will be employed. Campers will be instructed on basic offensive and defensive play calling as well as receiving skills and running of pass patterns.

Finally, they'll participate in flag football games.
